## When are Virtual ETS/PBI Audits Permitted?

- Policy 1: As always, the health and safety of employees at our member organizations and of our auditor partners is of utmost concern to our organization. Therefore, when health and safety is at issue, all audits may be conducted virtually.
  - Under Principle 1, virtual audits may be conducted for every module and applicable operations of the ETS/PBI Program.

#### When are Virtual ETS/PBI Audits Permitted?

- Policy 2: If health and safety are not at issue, a virtual audit may be conducted when:
  - A member has successfully completed a Global Stewardship Audit <u>before</u>
  - II. and the current audit is:
    - **a.** of modules primarily concerned with headquarter or office operations (General Stewardship, Incident Response Management).
    - **b.** of modules that may include partial headquarter or office operations and thus may be completed virtually with respect to the headquarter or office operations portion. (Product Launch, Product Discontinuation, Insect Resistance Management).
  - Audits that fall under Maintaining Plant Product Integrity and are therefore associated with physical operations may not be conducted virtually unless GSG gives permission.

### When are Virtual ETS/PBI Audits Permitted?

#### **Examples of valid use of Policy 1**

- a) An epidemic in the audit location or location where auditor is based.
- b) Acts of God, such as severe acts of nature or weather events including floods, fires, earthquakes, hurricanes, or explosions in audit location.
- c) A war in the location of the audit.
- d) When there are concerns regarding the personal safety of staff.

#### **Examples of valid use of Policy 2**

- a) Conducting an audit of the stewardship module virtually where evidence can be transmitted electronically.
- The audit of legal/contract documentation via computer for part of the IRM Module.
